Board News

We hope you have paid attention to maintenance and repair work that has been completed recently. Some examples are: swimming pool skimmer replaced; water pressure reducing valve replaced at the water meter between units 414 & 416; an independent contractor who is used frequently by David Floyd & Associate has done smaller repair/maintenance work on approximately 110 individual units. The work has addressed soffits, gates/fences, trim/siding and drainage problems, among others. And this type of work will continue.

In addition to the work already completed, the following contracts have been approved and the work is being scheduled to begin within the next couple of weeks.

PLEASE NOTE – there will be several workers on our Property to complete the following work, and they will be on-site for an Extended Period of Time until these Projects are completed. Jason Wright Painting: soffit, fascia, siding & trim work on over 106 units. Don Kennedy Roofing: 4" gutter repair on 18 units and installation of diverters on all carport gutters. The diverters will prevent water drainage onto the siding of trash holding areas.

Additional Work Items currently being addressed: Charles & Barbara Allen - replace 6 valves in the pool pump house. Bids are being obtained to cut back limbs overhanging roofs, raise the canopy on larger trees and remove some dead branches.

<u>New Signs</u> – Please notice the new "River Plantation – Section II" Sign at the corner of Sawyer Brown Rd. and Plantation Court, and the new Directional Sign at the "split" in front of Unit 400.

Winterization/Maintenance Items

With cold weather approaching, please ensure that your hoses are disconnected from your Spigots, and that your Spigots are insulated/protected from the Freezing Weather. Also, if you have not done it in a while, you may want to change your Furnace Filters, replace your Smoke Alarm Batteries, and check your Car's Battery and Tire Pressure.
